

TRADEWINDS PRODUCT WARRANTY

TRADEWINDS DISPLAYS, L.L.C, a Minnesota corporation, hereby warrants, as set forth below, for its products. Laminate, fabric or rollable laminate color variations due to changes by suppliers during the manufacture of materials are not covered under this warranty.

TRADEWINDS warrants products for a period of 1 year from the date of shipment. The warranty provides that products will be free from defects in material and workmanship for the period stated. Defects will be determined solely by TRADEWINDS, not by any representative, distributor, or dealer of/or for TRADEWINDS. Upon determination of defect, the sole obligation of TRADEWINDS will be to repair or replace defective part(s).

Exceptions for 1 year product warranty:

- TradeWinds fabric graphics have a lifetime warranty against manufacturer defects.
- Lighting fixtures have a 2 year warranty against manufacturing defects from date of shipment.

The conditions of the Limited Warranty are: (1) Products can only be subject normal use and service and shall not have been misused, neglected, altered or otherwise damaged and (2) There can be no evidence of tampering or deliberate destruction. The product and its components must be packed per supplied instructions and shipped in approved TRADEWINDS' specified packaging.

No representative or dealer of/or for TRADEWINDS is authorized to assume for TRADEWINDS any other obligations or liabilities in connection with the products, or alter the terms of this Limited Warranty in any way. This Limited Warranty is restricted to the express provisions contained herein and does not extend to the liability for labor cost incurred in replacing defective parts.

Authorization to return any alleged defective part must be obtained from TRADEWINDS before the alleged defective part is returned. (See TRADEWINDS' Return Authorization Policy and Procedure.) The buyer must prepay all shipping and transportation charges. TRADEWINDS will not accept charges for parts purchased unless the conditions of this Limited Warranty have been satisfied.

THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE HEREBY EXCLUDED BEYOND THE ONE YEAR DURATION OF THIS WARRANTY. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS. TRADEWINDS DISPLAYS, L.L.C. SHALL NOT BE LIABLE FOR DAMAGES, INCLUDING SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OUT OF OR IN CONNECTION WITH THE PERFORMANCE OF TRADEWINDS PRODUCTS, OR THEIR USE BY THE OWNER.

Any action resulting from the breach of this Limited Warranty must be commenced within one (1) year after the cause of action accrues. In no event shall TRADEWINDS' total liability for any or all breaches of this Limited Warranty exceed the actual purchase price of the products paid by the Purchaser.
